Office Order

The undersigned is directed to convey Government's approval of ex-Bangladesh leave in favor of Md Sabdul Islam, Union Parisad Secretary of Arainagar Union Parishad, Dhamoirhat, Naogaon for traveling to India for medical treatment for himself from 16-03-2024 to 30-03-2024 or from the date of departure for a period of 15 days from the date of availing the leave under the following terms and conditions. During his absence Mr. Milon Kumar Debnath, Union Parisad Secretary of Esobpur Union Parishad of the same Upazila will perform additional duties as a Union Parisad secretary of Arainagar Union Parishad.

Terms and Conditons:

1. He will not be entitled to claim any travel allowances from Bangladesh Government.
2. All related expenses of the visit will be borne by himself.
3. He will be eligible to draw all pay and allowances in local currency.
4. He will not be allowed to stay abroad more than the approved period.
5. He will have to join his working place at the end of the leave.
6. Authority can cancel the leave any time without showing any reason.
7. According to Local government (Union Parisad) Employee Service Rule 2011 and Notification No. S.R.O 253 rule/2013, on 22-07-2013, Upazila Nirbahi Officer will grant permission about the departure and send a copy of the order to the office of the Deputy Commissioner, Naogaon.


