Notes

1. The post of ADC, RDC, IAO, ADG and GCO in Astt 1150-1800 which is to be integrated at those of Senior Executive Commissioner, Revenue, Land acquisition, Local Govt., Bank Controller respectively.

2. The post of Wholesaling Trading Magistrates should also be in scale 1150-1800. They will all be vested with powers under section 19C of the Cr. P.C.

3. IAO establishment will be flexible depending on work load. Existing establishment in the bigger districts should continue.

4. Existing marine establishments should continue. In new riverine districts like Jorhat, such establishment will have to be added.

5. A.O.: This post is not borne on MSS(A) cadre. It is the only post filled up by promotion from among subordinate staff.

6. Protocol Officer: This post is specific to the districts of Dibrugarh & Cachar. Some Syndicate posts for extra AC with one link & one MSS have been included.

7. D.R.O.: DRDO with supporting staff will be provided by the Directorate General of Relief & Rehabilitation. They will be under local administrative control or D.C.

8. The post is not borne in MSS(A) cadre. Of the two Branches of the District Treasury the Treasurer's branch will be under the direct administrative control of the D.C. and an Asstt. Commissioner will act as Treasurer Officer in addition to his normal duties. Existing Treasury staff will continue subject to future adjustment. One personnel for Accounts branch will be posted by D.A. & AG.

9. IDA: This means IDA-CUM-Tributary Assistant is also an IDA.

10. All ACs will try criminal cases as part-time registrars and will also dispose of certificate cases.

11. In addition to his normal duties, GCO will look after the loan recovery matters. Two City Magistrate and one City Magistrate for Khulna & Rajbari districts respectively in scale 1150-1800 should be posted. They will have same staff as that of a Town Magistrate.

12. There will be one AC(City) for each of Rajbari, Kamrup Singh & Khulna district with standard supporting staff.

13. There will be one ADC(IA) for each of Dibrugarh, Cachar & Khulna districts with standard supporting staff. With standard supporting staff, required number of ACs (on probation) will also be posted for training.

14. There will be one ADC(IA) for each of Dibrugarh, Cachar & Khulna districts with standard supporting staff. With standard supporting staff, required number of ACs (on probation) will also be posted for training.
