NOTIFICATION

No. 849-ST—16th December 1963--In exercise of the powers conferred by section 74 of the Stamp Act, 1899 (II of 1899), as delegated to the Board of Revenue under the late Government of Bengal, Revenue (Stamps) Department Notification No. 996 ST, dated the 15th January 1938, the Board of Revenue is pleased to make with immediate effect, the following amendments in the Government of Bengal Rules republished in Section II of Part II of the Stamp Manual 1931, Volume I, at pages 137-141 and page 153, namely:

Amendments

(1) For existing rule 5 of the said Rules as amended by notification No. 1483 ST, dated 24th December 1960, the following shall be substituted, namely:

Subject to rule 6, every licensed vendor who purchases from the Provincial Government, by payment of ready money, stamps embossed or engraved on stamped paper, and adhesive stamps, shall receive the same at a discount at the following rates:

Handwritten note: Show to clerk to make & keep file in the office.

Non-Judicial Stamps.

At places where stamps are sold by the Provincial Govt. At other places.

Adhesive—

- (2) In rule 6 of the said Rules, for the figure "Rs.50" occurring in the second line, the figure "Rs.100" shall be substituted.
- (3) In rule 6A of the said Rules, for the figure "Rs.50" wherever it occurs, the figure "Rs.100" shall be substituted.
- (4) For the figure "Rs.50" occurring in the 3rd line of first condition of licence form at page 183 of Stamp Manual, the figure "Rs.100" shall be substituted.
