Your quotation, in duplicate, must be delivered to the office of the undersigned on or before 13/01/22 at 3.30 PM Any quotation received later than the scheduled time will be rejected and returned unopened. The envelope containing the quotation must be clearly marked "Quotation for Supply of Sub Mersible Motor Re- Winding Wire (PE) With Different Size" and DO NOT OPEN before-13/01/22 at 4.00 PM.
 - 4. All quotations must be valid for a period of Thirty (30) days from the closing date of the Request for Quotations.
 - 5. The quotation shall be completed and signed by an authorised representative of the Contractor. In the case of a Supplier offering to Supply of Sub Mersible Motor Re- Winding Wire (PE) With Different Size for use in BMDA. Atrai Zone, Naogaon.

The Supplier shall attach the following documents to its quotation;

- (a) A duly completed and signed priced offer as per the Schedule of Items and the Priced Quotation. Note that all prices shall be quoted in Bangladesh Taka;
- (b) A valid Trade License;
- (c) A valid TIN Certificate;

Terms and Conditions for the Supply of Sub Mersible Motor Re- Winding Wire (PE) With Different Size.

The Terms and Condition hereinafter may only be varied with the written agreement of the Purchaser and no terms and conditions put forward at any time by the Supplier shall form and part of the Contract.

- (a) the Supplier shall not be required to submit a performance security;
- (b) the Supply of the Goods within [2] weeks form the date of issue of the Contractor Order, or the signing of the contract (if applicable);
- (c) often supply of the Goods, Technical committee will be test and cirtify that the good condition of materials.
- after completion of Goods the Contractor shall submit an original Invoice, and two (2) copies, to the Contractor, VAT Taxes separately;
- payment of the Invoice shall be arranged by the Contractor, within thirty (30) days, but only against the actual quantities of the supply of Goods.
- (f) payments against VAT/Taxes and other impositions shown in the Contractor invoice shall be made either:
 - (xliii) through the Accountant General's Office, at the time of settlement of the Invoice; or
 - (xliv) in advance by the Contractor, who shall then submit the Treasury Chelan, (showing it has been paid through the Bangladesh Bank);
- (g) the purchaser may, by written notice sent to the Contractor, terminate the Contractor Order (or Contract if applicable) in whole or in part at any time for its convenience:
 - (lxxxv) if the supplier fails to complete the total supply of Goods.within the time period(s) specified in the purchase order, or
 - (lxxxvi) if the supplier fails to perform any other obligation(s) under the purchaser Order, or
 - (lxxxvii) if the supplier, in either of the above circumstances does not cure its failure within a period of (3) three calendar days after receipt of a notice of default from the Contractor specifying the nature of the default(s), or
 - (lxxxviii) if the supplier, in the judgment of the Contractor, has engaged in any corrupt or fraudulent practices in competing for or in executing the tasks under this work Order; and
- (h) The supplier shall provide the warranty, as stipulated in the Quotation document, for the goods to be supplier and confirm that if any faults are detected within the warranty period, in the supplier/installed works the supplier shall be bound to rectify the fault or replace the works as the case may be.
